



NEW VANUATU AGRICULTURAL POLICY BANK LAUNCH

AND AWARENESS WORKSHOP

CONCEPT NOTE

Proposed Dates: 7-10 September, 2015 **Venue: Port Vila, Vanuatu then Penama**

B. Background

Clear, evidenced based national agriculture/forestry ("AgF") policies are critical to ensure that there is a coherent plan for Government, farmers, private sector and other stakeholders to secure rural livelihoods, secure food security and collectively grow the agricultural sector and its contribution to national development.

Vanuatu's Ministry of Agriculture has recently completed its *National Agriculture Sector Policy 2015-2030. (See table summary below)* This has been an impressive achievement – a process of several years of hard work, consultations, review and planning. This overall National document gives key stakeholders a synthesis of key priorities, issues and how they might be achieved. While a National Agriculture Policy document sets the overall framework, 'sub-sector' plans, industry plans or policies are also put in place to help progress specific commodities, products or industries. Many of these sub-sector plans/policies such as biosecurity, livestock, coffee etc for Vanuatu are in already place or are being updated. There are also new ussyes

The Challenge

Policies need to be made easily accessible to all key stakeholders. Most Agriculture/Forestry policy documents in the Pacific are available only in hardcopy form. Limited resources often mean that these documents have limited circulation and therefore not easily accessible – not only to national stakeholders but also international investors, development partners, researchers and other institutions. A recent SPC policy study also showed that policy national Ag/F Policy documents can vary in length and readability. PNG and Tonga national documents stretch to almost a hundred pages. Detailed documents need to be translated into succinct forms – written or orally - so that farmers and stakeholders can easily understand the contents of key policy documents. The legal and policy context within Government is also important for clarity. The Agriculture sector itself may be governed by several legislations and cross-cutting national policies and implemented by different actors, Ministries, agencies etc. Examples are trade, HACCP, quarantine, food security, rural development, youth and health.

Through the SPC Pacific Agriculture Policy Agriculture, Vanuatu's Ministry of Agriculture has established its first ever <u>Vanuatu Agriculture Policy Bank</u>. Vanuatu <u>will be the first country</u> in the Pacific to launch such a policy bank for agriculture. This aims to provide:





- (i) A repository of key National Agriculture Policy Documents covering sector and subsector plans/policy documents. This means documents will be easily accessed online nationally and internationally;
- (ii) Translated summaries of key policy documents (English and Bislama) This will enable easier dissemination to the public and rural stakeholders including forming the basis of rural radio outreach;
- (iii) A policy map of key documents and which actors lead key related Policies.

C. What is Planned?

Three events are planned for the week starting 7 September 2015. These are
