SEPTEMBER 2015

- I am pleased to announce that the European Union supported Pacific Agriculture Policy Project (PAPP) implemented by the Secretariat of the Pacific Community, in collaboration with the Vanuatu Ministry of Agriculture, Livestock, Forestry, Fisheries, and Biosecurity and the Technical Centre for Agriculture and Rural Cooperation (CTA) will be conducting the following workshops in Vanuatu.
 - Convene a sub-regional knowledge management workshop on 'Strengthening regional knowledge management capacities to support agricultural policy, research and markets linkages', from 7 – 10 September;
 - II) Launch the Vanuatu Agricultural Policy Bank including an awareness workshop on Vanuatu's new National Agricultural Policy from 10-11 September 2015.

OBJECTIVES OF THE WORKSHOPS

- 2. The overall objectives of the workshops are to:
 - (i) Promote easy access to key policy information.
 - (ii) Strengthen regional knowledge management capacities to support Agricultural policy in the Pacific region.
 - (iii) Promote awareness on the new Vanuatu Agricultural Policy Bank.

BACKGROUND

3. The European Union supported Pacific Agriculture Policy Project, implemented by the Land Resources Division of the Secretariat of the Pacific Community (SPC), aims to increase the capability of Pacific regional organisations to address the development needs of smallholder agriculture, by improving the linkages between small and medium farmers and markets. The Pacific Agriculture Policy Project (PAPP) is part of the EDF-10 Intra ACP Agriculture Policy Programme across the Pacific, Caribbean and the Indian Ocean. The Technical Centre for Agricultural and Rural Cooperation (CTA) coordinates the inter-regional exchanges between the Pacific and Caribbean.

- 4. Clear, evidence-based national agriculture and forestry policies are critical to ensure that there is a coherent plan for governments, farmers, private sector and other stakeholders to secure rural livelihoods, ensure food security and collectively grow the agricultural sector and its contribution to national development. Vanuatu's Ministry of Agriculture has completed its National Agriculture Sector Policy 2015 2030.
- 5. This overall national document gives stakeholders a synthesis of key priorities, issues and how they might be achieved. SPC through its Pacific Agriculture Policy Project is supporting the development of the first ever Vanuatu Agriculture Policy Bank which will be launched in Vanuatu on 10 September 2015. The aim of the Policy Bank launch is to provide:
 - (i) A repository of key National Agriculture Policy Documents covering sector and sub-sector plans and policies. This means documents will be easily accessible online nationally and internationally;
 - (ii) Translated summaries of key policy documents (English, French and Bislama). This will enable easier dissemination to the public and rural stakeholders, including the outreach through cross media platforms such as rural radio programmes, television and print.
 - (iii) A policy map of key documents and which actors lead key related Policies.
- 6. SPC PAPP is also assisting countries to strengthen knowledge management capacities to support agricultural policy. Promoting clear and relevant information flows between SPC, governments, farmers, exporters and other stakeholders and ensuring that information can reach communities at scale is one of the objectives for the European Union funded Pacific Agriculture Policy Project.
- 7. SPC PAPP has developed an Information and Knowledge Management (IKM) Strategy (2015-2017) that will provide a guide as to how the SPC might maximise delivery and uptake of relevant existing and deliver new knowledge products and services for the benefit of member countries.
- 8. In complement to the official Vanuatu policy bank launch programme, SPC PAPP is hosting its first sub-regional knowledge management sensitisation and awareness workshop to support regional, national and sectoral agriculture policies. A key objective of the workshop is to improve capacity strengthening of member countries through exchange of knowledge. The workshop will take place in Vanuatu from 7–10 September with a focus on sub-regional knowledge management scans.

VENUE

9. The regional knowledge management workshop and the Vanuatu policy launch will be held in Port Vila, Vanuatu.

DATES

10. The workshop dates are 7–11 September 2015.

The European Union funded Pacific Agriculture Policy Project (PAPP), implemented by the Secretariat of the Pacific Community (SPC), in collaboration with the Vanuatu **Ministry of Agriculture**, Livestock, Forestry, Fisheries, and Biosecurity (MALFFB) is funding the workshop in collaboration with the Technical Centre for Agriculture and Rural Cooperation (CTA).

PARTICIPANTS

- 14. Participants will be public sector staff from Cook Islands, Federated States of Micronesia, Fiji, Kiribati, Marshall Islands, Nauru, Niue, Palau, Papua New Guinea, Samoa, Solomon Islands, Tonga, Tuvalu, Vanuatu and Timor Leste for the Knowledge Management Scan.
- 15. Participants in the Policy Bank launch and the Vanuatu Agriculture Policy workshop will primarily be from the private sector, agriculture, forestry & fisheries, research and extension institutes, and regional and international organisations.

NOMINATION OF PARTICIPANTS

The nomination of participants will be facilitated through SPC Pacific Agriculture Policy Project. All nominees should reach the workshop organisers (with full names and contact details) by 21 August 2015.

TRAVEL AND FINANCIAL ARRANGEMENTS

- 17. The workshop organisers will provide the following for nominated participants:
 - a. A round trip or return air ticket by the most direct and economical route from his/her capital town to Port Vila, Vanuatu. All tickets must be used as issued or authorised. Any other extra costs other than the authorised tickets will be at the participant's cost.
 - b. The Secretariat will be responsible for reservation and payment of hotel rooms for sponsored participants. Names of participants (Annex 2 Nomination form) should be sent to the Secretariat no later than 21 August 2015 for early confirmation of room reservations. No payment will be made to participants who decide to stay elsewhere unless approved by the organisers. [Non-sponsored participants are asked to make their own hotel bookings at any of the authorised hotels or other hotels of their choice.]
 - c. Participants shall make their own arrangements for accommodation and airport transfers on transit to and from Port Vila, Vanuatu.
